<u>Treasurer Report:</u> Unanimously Approved, Mark Kurtz & Randy Covington; motion to approve & second Old Business:

1. Mike Holbrook communicated that many members had voiced concerns over the current pet policy. Several members stated the current policy is too vague and is not being enforced. Therefore, a new Pet Policy was presented to the Club. A Motion and Second was made; the members approved unanimously.

- b. Pet Policy will be adopted to the Field Rules & Regulations which require no By-Law change.

- 2. During the September meeting a detailed discussion took place among the membership about guest invites. Those discussions are in the September minutes. It was decided we would wait to the October meeting in order to present a proposed solution. Mike Holbrook communicated to the members in order to change the By-Laws, two votes must pass. One at a regular meeting and the final vote goes out to the entire membership. The proposal discussed was as follows:
  - a. For any invited NEW Guest, the first visit is deemed a Grace Period, meaning no fee. The invited guest is allowed to fly at the RAMS Field two more times within a fiscal year at a fee of \$35 per visit. This can be paid by the non-member or the member who initiates the invite. The RAMS Member who invites is responsible for getting the guest pass funds to the Treasurer.
    - After the three visits have expired, the Guest is expected to join the Club to fly more at the field.
  - b. For any invited guest who is new to the RC Sport, three no charge guest passes are granted. After the three visits expire, the Guest is expected to join the Club.
    - 1. Motion: Charlie Lasley Second: John Welcome
    - 2. The motion passed unanimously and will be sent out to the entire club for ratification.
    - 3. RAMS Events already carry a fee and do not apply to this policy.
